National Route Setters EXPRESSIONS OF INTEREST – 2024/2025

We are seeking expressions of interest (EOI) from all Route Setters for the upcoming 2024 - 2025 season.

We are interested in receiving applications from all setters, national and international. We are looking to build a pool of Route Setters and Chief Route Setters. We may also review our pool of applicants when we have opportunities to develop in the future.

These applications may be reviewed by CNZ; CNZ reserves the right to choose a Head Setter per competition. The Head Setter and relevant CNZ personnel may choose a setting team for each competition separately.

Applications close 2nd August 2024

Level 4 (Chief Route Setter)

Responsibilities:

- Providing insight and justification within the selection process of the team
- Keeping up to date with all relevant rules and regulations surrounding route setting within NZ and as per IFSC
- Meeting the expectations outlined by Climbing New Zealand for each event
- Providing leadership and mentorship to the rest of the Routesetting team
- Coordinating with Climbing New Zealand, P.O.J and Event Management
- Overseeing the forerunning of all blocs/routes
- Overseeing the design and implementation of all routes and Boulders
- Ensuring Health and Safety is kept to relevant national standards
- Providing feedback to all setters for further development
- Ensure H&S venue related, logistics and accountability for any careless damages to the facility equipment, walls, floors, staff, management.
- Any changes to planning of the event must be made in writing to CNZ, POJ, and Facility Manager.

Level 3 Senior Route Setter

- Meeting the expectations outlined by Climbing New Zealand and the chief routesetter
- Providing leadership and mentorship to the rest of the Routesetting team
- Designing, setting and forerunning routes/blocs
- Ensuring Health and Safety is kept to relevant national standards

- holds height safety qualification (lead climbing only)
- any relevant qualifications are a bonus

Level 2 Route Setter

- Assisting senior setters with routes/blocs
- Designing, setting and forerunning routes/blocs

Level 1 Entry Level Route Setter

Responsibilities:

- Keeping up to date with all rules and regulations surrounding route setting within the nation and IFSC
- Meeting the expectations outlined from Climbing New Zealand and the chief routesetter
- Assisting senior setters with routes/blocs
- Designing, Setting and Forerunning Routes/Blocs
- Ensuring Health and Safety is kept to relevant national standards

Qualifications/Experience

- at least 2 years route setting
- Holds height safety qualification (lead climbing only)
- Any relevant qualifications are a bonus
- Can climb at least v6/26 (can also be at the discretion of the selection committee)

CNZ suggests the following pay scale, yet to be confirmed:

Level 4: Chief routesetter

Day rate \$300-\$350

Level 3:

Day rate \$250-\$280

Day rate: \$192

Travel and accommodation costs:

CNZ may pay a set night rate for travel and accommodation depending on travel distance.

Within 50km of venue: No contribution

Travels from within 50km - 200km of venue: \$50 per night

Travel on same island but more than 200km: \$75 per night

Travel from the other island: \$100 per night

Please note the contribution rates paid by CNZ may be the lower of actual travel and accommodation cost and max of per night, proof of costs required. Meals are not covered by CNZ, but we may have a team meal the day before or of the competition.
